

OUR ADVOCACY EFFORTS

Building Relationships with Ministers and MLAs

Each year, the TLA hosts well-attended caucus meetings for the **NDP and Liberal** parties where TLA directors engage in one-on-one conversations with legislative members to raise awareness about forest industry issues that affect their constituents.



Several times throughout the year, the TLA meets with the **Minister of Forests, Lands, Natural Resource Operations and Rural Development** to raise forestry issues and discuss policies that impact timber harvesting contractors. We provide the contractor's perspective and advise the ministry on solutions for legislative changes.



In January 2020, **Premier Horgan** met with the TLA executive and Board of Directors at the TLA's convention. Held in Vancouver, we created a space for the Premier and our directors to connect directly to discuss issues and the actions our industry requires from government.



Commitment to Working with First Nations

The TLA has a long history of working together with **First Nations**. In 2018, we began implementing a work plan that will further develop our relationships, including the development of the document, *How to Create a Good Working Agreement*.

Building Relationships with Resource Communities

The **TLA Mayoral Forestry Dinner** held each year during the Union of BC Municipalities (UBCM) convention is attended by more than 80 mayors from across the province and creates an opportunity for valuable conversation between community leaders and TLA directors.

Commitment to Safety

The TLA is committed to ongoing and diligent work with **WorkSafeBC and BCFSC** to provide input on safety related issues and timely information to members with the goal of ensuring they arrive home safe every night.

Working For You:

Contractor Sustainability Review

The Contractor Sustainability Review culminated with an announcement by **Premier Horgan** at the 2019 TLA convention that the fair market rate test would be eliminated. Our ongoing work is to ensure the new regulation is implemented correctly, accurate cost data is collected to support the process, and members are educated to ensure its intent is met. The Premier has committed to moving forward with the policy and regulation changes by spring 2021.

Protecting our Working Forest

Over concerns about the impact of ENGOS sharing misinformation about old-growth logging, the TLA has been diligent in sending letters to MLAs and ministers, letters to the editor, doing media interviews and writing OpEd articles to ensure the TLA's voice is heard and the public receives correct information. In response to government's **Old Growth Strategic Review**, the TLA Board met with the two-person panel, submitted an online submission and completed the online questionnaire.

Fostering a Stronger Forestry Sector

The TLA has been working to collaborate with all levels of government, including resource communities, to help mitigate the impact of policy changes in an effort to foster a stronger forestry sector in BC. While our primary goal is to protect our members, we will work diligently to provide input towards improving the forestry sector in all aspects.

TLA Forestry Equipment Hourly Rates

In fulfilling our mission to promote the viability of the TLA membership by promoting contractor sustainability and fostering successful relationships that support our vision, we were very proud to partner with TimberTracks to develop **Forestry Equipment Hourly Rates**. The rate sheet helps to educate all contractors in the province on the value of their working equipment and improves our members' sustainability.
